A MESSAGE FROM THE BOARD PRESIDENT



Dear Friends of the Community Chest,

2016 was a very successful year for The Community Chest. We completed a strategic plan that will guide our work over the next three years. We are staying true to the original mission of our founders, but are changing the way that we work to ensure continued success. While many of the community needs are the same, we realized that we must approach the challenges of fundraising and community support in new ways in an ever-changing world. Thanks to the input from our Board, our agencies and community representatives, we believe the plan will enable us to be successful over the coming years.

We had a very strong fundraising year. Corporate sponsorships for our events is a growing source of funding for our activities. More than 700 individuals, families and businesses responded to our Annual Appeal Campaign where we ask neighbors to help neighbors. We also raised a record amount from our two fundraising events, thanks to a team made up of dedicated Board members and community volunteers. We are very fortunate to have such a great team that puts in the hours and efforts to make the events successful.

In 2016, we awarded over \$200,000 to local agencies to help them continue to do the good work they do. \$170,000 was awarded during the annual grant process. We funded a new agency – West Side Infant and Teen in Englewood. \$25,000 was awarded to Vantage Health Systems as this year's recipient of the Tanner Impact Grant. Vantage will use the grant to provide medical services to patients of their mental health clinics. This is a very important and needed service and we are proud that our funding will enable them to start up the program. During the Holiday season, we awarded \$5,000 in gift cards to 5 of our agencies. Cards were distributed to 180 of their clients to help them get more enjoyment in what might be a difficult time.

Finally, we continued our Leadership Development program, supporting the staff of the nonprofits in our area. By combining this with our Executive Director's collaboration sessions, and our internships for high school and graduate students, we are finding new ways to build capacity and improve the delivery of vital services to help make the community an even better place to live.

I want to again thank our Board members for the work they do to keep our mission alive. I also want to thank the individuals and business donors for their generosity. And thank you to the agencies who do all the work for their clients and our community.

Dear Friends.

This was a great year for The Community Chest. We made a decision to embark upon a Strategic Plan and we did it! We

appointed a great committee chair, our board member, Jayanne Tedesco, assembled a great team of workers and hired a great consultant, Kirsten Richert, to help us. With their combined wisdom and energy, we created an exciting Strategic Plan that will take us through 2019. (Go to our website at www.thecommunitychestofenglewood.org to view the plan)

At first it seemed like an awesome task but the more we thought about who we are, what we believe in, and what lies ahead the more excited we became. We believe in helping those in our community who are unable to help themselves. We want to offer that help through as many venues as possible. This year we granted funds to 23 local agencies. We look forward to doing the same in the years to come.



Through our many conversations with community members, we recognized our potential as a community leader and felt that we were ready to take a stronger leadership role in helping our local community to understand its needs and figure out how to address them. We are exploring the issues that confront our community and we are seeking ways of addressing them.

Through our Professional Development Program, offered in collaboration with Rutgers School of Social Work, Department of Continuing Education, we are offering educational opportunities to the staff of the agencies we serve. The response to these sessions has been overwhelmingly positive and the agencies are enthusiastically awaiting a new year of learning. We are exploring the possibility of offering a Certificate Program in Management through Rutgers which we hope to launch in Spring 2017.

We consider ourselves champions of philanthropy and we want to be as knowledgeable as possible about charitable giving. We believe that we are the ideal organization to help generous people make decisions about how and where to give their money. We want to do that for people of all ages. We have teamed up with experts to expand our knowledge about charitable investments and will be offering seminars throughout the year to educate citizens about how they can support the nonprofit community.

We have embarked on a journey to educate others. We will be building a new generation of donors through our work with young children in local elementary schools and will be moving on to high school students and then to young adults. We will be helping people of all ages find their most comfortable way of sharing themselves with others. We are seeking sponsors of these educational sessions to ensure that they can be offered at no charge to participants.

Our plans are bold and exciting. We welcome our friends and donors to join us in this great undertaking. We know that that cannot do it alone but we feel confident that we can do it.





COMMUNITY IMPACT

Grantmaking



In 2015, The Community Chest awarded grants to 23 local nonprofits that delivered a range of much needed services to our community, including social programs for seniors, afterschool enrichment, medical and mental health services, job training for women in transition, college scholarships, food distribution, parenting education, environmental stewardship, arts programming, and more. In just the past year, we were able to **improve the lives of 50,000 people** in eastern Bergen County.

A total of \$170,100 was awarded in the form of annual grants, including one new grantee, West Side Infant and Teen Program. An additional \$25,000 through a Tanner Impact grant was awarded to Vantage Health System for the launching of a medical program for clients enrolled in Vantage programs. During the holiday season, we were pleased to give \$5,000 in holiday gifts cards to 5 agencies which were then distributed to 180 individuals.

The YWCA's \$7,500 grant provides more than "just" swim lessons; it provides the YW with an opportunity to right a historical wrong. Our grant from the Community Chest provides scholarships for swimming lessons, thereby ensuring that everyone has access to this essential life skill. "

Planned Parenthood About a month ago, a woman in her mid-30's came in for a follow-up to her abnormal pap screen. The patient was very quiet and appeared very scared. Our physician performed a colposcopy and provided the patient with information and possible next steps. Fortunately, the patient did not have cervical cancer but an infection. The patient received the necessary medication and follow-up appointments. As we checked her out, staff asked her if there was anything else that we could do for her, the patient replied, "no thank you, you changed my life". As it turns out, the patient and her daughter had recently been in a horrific car accident leaving them both with physical disabilities. She has been unable to return to work, and finances have been tight. The news of an abnormal pap smear was almost more than she could bear. --Lisa A, Englewood, NJ

LEADERSHIP DEVELOPMENT

Professional Development Series

This year we continued our Professional Development Series, launched in 2014, offered for agencies receiving funding from The Community Chest. In response to the demands on nonprofit managers to acquire a new set of skills to prepare them to better meet the requirements of donors and government, the goal of this training series is to assist local agency staff with updating their skills in management and supervision. Through a relationship with Rutgers University School of Social Work's Department of Continuing Education we have secured graduate level instructors, with specially designed curricula, to offer half-day classes on selected topics. Continuing Education credits to be used toward Social Work licensing are available for some of these classes, based on the workshop topic and the trainee's need. This series is also available to other non-profit organizations who are not grantees of The Community Chest. We are grateful to Englewood Rotary Club for their ongoing support as well as SUEZ, TD Bank and PSESG.

Social Work Ethics: Dealing With Serious Practice Challenges	This workshop examined the ethical and professional responsibilities that social workers have to their clients, colleagues and to the profession.
Cultural Competence Skills: Bridging Cultural Differences with Respect and Understanding	The focus of this workshop was on ethnic and cultural differences, as well as other forms of difference including ability/disability, religion, and sexual orientation.




FINANCIALS
